

**Parental/Guardian Consent Form  
for Riders Age 17 and Under  
2011 Over the Top Ride**

In consideration of being permitted to participate in any way in the *Over The Top Cycle Ride* (the *Event*) sponsored bicycling activities (“Activity”) I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. Acknowledge, agree, and represent that I understand the inherently dangerous nature of Bicycling Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further acknowledge that the *Event* will be conducted over public roads and facilities open to the public during the *Event* and upon which the hazards of traveling are to be expected. I further agree and warrant that if, at any time, I believe conditions to be unsafe, I will immediately discontinue further participation in the *Event*.

2. I fully understand that (a) Bicycling Activities involve inherent risks and dangers of serious bodily injury, including permanent disability, paralysis and death (“Risks”) (b) these Risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the *Event*, the condition in which the Activity takes place, or the Negligence of the “Releasees” named below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation or that of the minor in the Activity.

3. I hereby Release, Discharge, and Covenant not to sue the Oakridge Hostel, LLC, The US Forest Service, or McKenzie River Resorts their administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers and if applicable, owners and lessors of premises on which the Activity takes place. (each considered one of the “Releasees” herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by my negligence of the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability,

assumption of risk I, or anyone on my behalf, make a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss, liability damage, or cost which may occur as the result of such claim.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and in consideration for being allowed to participate in this event. If any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.

In addition, I agree to cycle in a safe, courteous, and lawful manner when participating in the *Over The Top Ride* and to encourage the same among fellow riders and other participants.

### Minor Release

And I, the child's parent and/or guardian, understand the nature of bicycling activities and the child's experience and capabilities and I believe the child to be qualified, in good health, and in proper physical condition to participate in such activity. I hereby release, discharge, covenant not to sue, and agree to indemnify and save and hold harmless each of the releasee's from all liability, claims, demands, losses, or damages on the child's account caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or others, including negligent rescue operations and I further agree that if, despite this release, I, the child, or anyone on the child's behalf makes a claim against any of the releasees named above, I will indemnify save, and hold harmless each of the releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost any may occur as the result of any such claim.

I understand and agree that a ride marshal or employee of the *Over The Top Event* may disqualify my child from this event if their conduct or behavior is inconsistent with safe cycling practices or if their conduct or behavior is offensive to other participants. In the event of my child's disqualification I will not receive any refund of the fees paid.
