Riders will be about equally split between the starting points.

Lodging

Friday and Saturday night lodging is included in the registration fee. The primary lodging and check-in point in Oakridge is the Oakridge Hostel, with space for 25 guests. Additional lodging will be arranged through local motels a short distance away. Likewise in Blue River, the primary lodging and gathering place for the ride is the McKenzie River Mountain Resort. Additional lodging will be arranged with nearby motels as needed.

Safety

Cyclists must wear safety rated (CSPC) helmets while underway on the ride.

Cyclists must observe all applicable laws and must ride in a safe and courteous manner. Multiple aid stops along the route will provide fresh snacks, hydration, and comfort stations. The ride is fully supported with baggage transfer, mechanical support, SAG, and friendly greeters.

SAG: The course will close at 5 PM. Riders still out will be given an opportunity to ride the sag to their destination. If they decline, they will be on their own.

In consideration of being permitted to participate in any way in the *Over The Top* sponsored bicycling event ("Event") I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. Acknowledge, agree, and represent that I understand the nature of Bicycling Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further acknowledge that the *Event* will be conducted over public roads and facilities open to the public during the *Event* and upon which the hazards of traveling are to be expected. I further agree and warrant that if, at any time, I believe conditions to be unsafe, I will immediately discontinue further participation in the *Event*.

2. Fully understand that (a) Bicycling Activities involve risks and dangers of serious bodily injury, including permanent disability, paralysis and death (“Risks”) (b) these Risks and Dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the *Event*, the conditions in which the *Event* takes place, or the Negligence of the parties named below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation or that of the minor in the *Event*.

3. I do Hereby Release, Discharge, and Covenant not to sue the Oakridge Hostel, LLC or McKenzie River Resorts their administrators, directors, agents, officers, members, volunteers, and employees, other participants, sponsors, advertisers and if applicable, owners and lessors of premises on which the Activity takes place. (each considered one of the “Releasees” herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by me negligence of the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk and indemnity agreement I or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss, liability damage, or cost which any may incur as the result of such claim.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and in consideration of being allowed to participate in this *Event*. If any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.

In addition, I agree to cycle in a safe, courteous, and lawful manner when participating in the *Over The Top Event* and to encourage the same among fellow riders. I understand and agree that a ride marshal or employee of the *Over The Top Event* may disqualify me from the *Event* if my conduct or behavior is inconsistent with safe cycling practices or if my conduct or behavior is offensive to other participants. If I am disqualified, I understand that I will not receive any refund of my fees.
